## RULES AND PROCEDURE

**KINDLY TAKE NOTE OF ALL THE RULES**

### ***PRELIMS ROUND -KNOCKOUTS, QUARTERS AND SEMIS - 13<sup>TH</sup> JULY***

- There shall be a total of 3 Rounds for the Prelims – Knockouts, Quarters and the Semis.
- There shall be 4 Questions each from the Subjects as mentioned below, in all the 3 Rounds. :-  
Constitutional Law  
Criminal Law  
Contracts Law  
Legal Maxims  
Parliament of India  
Supreme Court
- There shall not be any Negative Marking.
- The Questions in the Knockouts and Quarters shall be of Easy level and General in nature. The Questions in the Semis will be Moderate and a little tougher.



- The Prelims rounds shall be conducted post 7 P.M. on 13<sup>th</sup> July '2019. We shall notify the time by 9<sup>th</sup> July '2019. You need to submit the quiz well within the assigned Time.
- You shall receive another Email by 9<sup>th</sup> July which shall have the **WHATSAPP OFFICIAL GROUP LINKS**. You have to mandatorily Join the same, **AS THE LINK OF THE QUIZ SHALL BE SENT VIA THE GROUP**.
- The Results of the Prelims Rounds shall be declared within 3 hours of the conduction of the Rounds.
- **TIME SHALL PLAY THE MOST ESSENTIAL FACTOR AND YOUR SCORES WOULD COMPLETELY DEPEND UPON THE SAME. IF THERE IS A TIE, THE SAME SCORES UPTO THE TIE SHALL BE ACCOMODATED IN THE QUALIFYING ROUNDS.**
- **KNOCKOUTS – THE TOP 140 PARTICIPANTS MOVE TO THE QUARTER FINALS.**
- **QUARTERS – THE TOP 80 PARTICIPANTS MOVE TO THE SEMI FINALS.**
- **SEMIS – THE TOP 10 PARTICIPANTS MOVE TO THE FINALS.**



## ***FINAL ROUND – 14<sup>TH</sup> JULY***

- The Rules, Questions, Marks for the Final Rounds remain same as that of the Prelims.
- The Questions will be Moderate to Hard level.
- The Timings shall be informed by 9<sup>th</sup> July '2019.
