RULES AND PROCEDURE

KINDLY TAKE NOTE OF ALL THE RULES

PRELIMS ROUND – 13TH JULY '2019

- There shall be 2 PRELIMS Round, the top performers of which move to the Finals.
- All the Participants shall be provided with a Factual Situation and the Applicable Law to it. The Participants shall as well be allotted the Petitioners and the Respondents side. Each Participant would have to then provide their Arguments on behalf of their side, in the written form.
- There shall not be any specific format for writing the Arguments and it certainly depends upon the participant. The Adjudication shall solely be on the basic of *cohesion, quality of content, reasonableness and strength of the argument*.
- All the Participants shall be provided with a Petitioner/Respondent Code.

- To maintain transparency, all the Arguments of each participant shall be shared with all the participants, via the team code. This shall further act as a great platform to learn from mistakes.
- You shall receive another Email by 9th July which shall have the **WHATSAPP OFFICIAL GROUP LINKS**. You have to mandatorily Join the same

- The Factual Instance shall be made available on 11th July '2019 at 9:00 A.M. The Deadline to Submit the same shall be 12th July 6:00 P.M.
- The Factual Instance for Round 2 shall be made available on 13th July 3:00 P.M. and the Deadline to Submit the same shall be 13th July 11:00 P.M.
- The Participants who successfully qualify Round 1 shall move on to the Round 2.
- **ROUND 1 – TOP 60 PARTICIPANTS MOVE ON TO ROUND 2.**
- **FINALS – TOP 10 PARTICIPANTS MOVE ON TO THE FINAL ROUND.**
