### **NATIONAL LAW QUIZ**

A quiz is generally a frequent and short assessment that can gauge a student's retention and comprehension of a small amount of information. A quiz can function throughout a course as an informative feedback device allowing both the instructor and the students to see where they are excelling or need more focus. To reinvent the education system and give students a break from traditional classroom learning, there is a dire need to revive the quiz culture in schools and colleges. We hence aim to keep the legacy alive by conducting regular quizzes at fixed intervals.

The Law Learners has been conducting quizzes at national level for last 4 months aiming to inculcate floating and dynamic knowledge among the people. The takers and the winners are being provided with exciting opportunities, certificates, publications and other recognitions extending to cash prizes.

The National Quizzes of The LAW Learners are increasingly being approachable and taken by exorbitant number of people Nationwide. The 5 Law Quizzes conducted previously witnessed as many as 620+ applications and takers.

The 6<sup>th</sup> National Law Quiz under the Lextravagenza 2019 shall be the FIRST OFFLINE quiz conducted by The LAW Learners. We promise to circulate good amount of legal knowledge and provide a dynamic platform for showcase of Legal comprehension for the takers.

The detailed rules and information about the quiz is as under-

#### **ELIGIBILITY CRITERIA & TEAM COMPOSITION**

• The language of the Competition shall be English and Hindi both.





- Anyone is eligible to participate.
- Any number of teams can register from an Institution.
- Participants have the liberty to make a team of 2 or 3 members. However, Single participation is not allowed.
- Participants of a team may be from different Institutions. Inter College participants are welcome.

#### FORMAT OF THE COMPETITION

- There shall be **2 ROUNDS**:- the Preliminary Written Round & the Final (Championship) Round. All teams shall participate in the Preliminary Written Round and only top 6 teams will qualify for the Final (Championship) Round.
- **PRELIMINARY ROUND**:- The time limit for the Preliminary (Written) Round will be 30 minutes and it shall contain 50 MCQ type questions, each carrying 2 points. However, for each incorrect answer there will be a deduction of 0.25 points. The questions shall be from the syllabus as specified below.
- **FINAL ROUND**:- The top six team will then compete in the championship round which will be an oral round. The final (Oral) round will consists of 5 Rounds in toto.
- **ROUND 1**:- 5 Questions shall be put up before each team, and each correct answer results into 6 points, however there is no negative marking for an incorrect answer. If a team is unable to answer, the question shall pass on to the next team. This round shall witness elimination of 1 team. The top five team will then qualify for the Round 2 of the final round.
- **ROUND 2**:- 5 Questions shall be put up before each team, and each correct answer results into 6 points, however there shall be negative marking of -3 for an incorrect answer. If a team is unable to answer, the question shall pass on to the next team. This





round shall witness elimination of 1 team. The top four teams will then qualify for the Round 3 of the final round.

- ROUND 3:- This round shall be Landmark Judgements Round. There shall be 3 questions for each team and they shall focus on Landmark Judgements. Each Correct answer results into 6 points, however there shall be negative marking of -3 for an incorrect answer. No team shall be eliminated.
- **ROUND 4**:- Round 4 shall be a Rapid Fire Round. Each team shall be asked as many questions as possible within a span of 90 Seconds. Each Correct answer results into 6 points and each incorrect answer results into -2. The team with the lowest score shall be eliminated.
- **ROUND 5**:- The final phase of the final round will be an answer 'till death round', in which each team will be asked questions till they fail to answer and the team shall be awarded +3 points for each correct answers.
- The team with the highest score at the end of the final round shall be declared as the winner.

- Legal Current Affairs 2017,2018 and 2019.
- Criminal Law General and Basic in nature
- Contracts and Torts Law General and Basic in nature

#### **MISCELLANEOUS**

• The result of the championship round will be announced at the valediction ceremony.





- The time limits for each phase of the championship round shall be declared by the Quiz master just before each phase of the championship round.
- In case of any tie, in any of the rounds the quiz master shall pose tie breaker questions to the teams.
- The organizers reserve the right to take appropriate action for any unethical, unprofessional and immoral conduct.
- The Rules specified herein above shall be strictly adhered to. The Organizing Committee reserve the right to disqualify teams for deviating from the Rules.
- The Committee will resolve any contingencies that may arise during the conduct of the Quiz and will be the final arbiters regarding any doubts / grievances.
- The decision taken by the Committee shall be final and binding. These rules are not exhaustive.
