NATIONAL JUDGMENT WRITING COMPETITION

The Judgment writing competition entails to capture the art of decision making in budding lawyers aspiring to join the reputed judicial services and to unfold the dynamic role of the Judges in relation to society.

The judgment writing competition involves a comprehensive approach towards law in terms of theory & implication of law.

THEME :

Participants shall be provided with the facts of an imaginary case which include the facts and arguments from both the sides, 60 minutes before the competition commences. Post completion of the 90 minutes, they would be given a duration of 60 minutes to complete their judgement.

It is to be noted that the case would be relatable to Constitutional Law and Criminal Law primarily, among others.

RULES FOR THE JUDGMENT WRITING COMPETITION :

- Participants may choose to participate in a Team of 2 or may participate alone.
- Participants of a team may be from different Institutions. Inter College participants are welcome.
- The judgement should be of minimum 1200 to maximum 2500 words.

- The judgement shall be a hand written one with the facts issues and arguments already provided to them at the time of the competition. They need to decide the case on the basis of the merit and give their respective judgments.
- The Case shall be disclosed 60 minutes prior to the start of competition.
- The participants shall get 60 minutes to write the judgement.
- Participants would not be allowed to use any technical gadget, once the facts of the case have been declared.
- The results shall be solely on the discretion of the organizers.
